2. INV: was sleeping and missed a phone call from Christopher Rainey. Rainey texted , "you don't care about me," at approximately 2230hrs. told Rainey to go to bed and leave her alone. At approximately 2310hrs, Rainey showed up at 's residence and continued calling and texting texted back, "I will not open the door." Rainey replied "I'm here and I will bust out the window."

At approximately 2320hrs, went outside to talk to Rainey. After approximately 10 minutes, Rainy became irate and told Rainey to leave. went back inside her residence. At approximately 2347hrs, Rainey texted "Don't go a sleep," and went outside to make sure Rainey was gone. He was gone, and at approximately 0022hrs, Rainey texted ur???" At his point, fearing for her life and the life of her family called LEO.

After I made contact with , I asked her to call Rainey so I can talked to him. When told Rainey that LEO wanted to talk to him, he replied, "wait and see what happens when they leave."

's sister. witnesses the above incident.

Post Miranda Rainey admitted to texting her "Time to Die Bitch u and ur???" and to showing up at her residence. He denied saying, "wait and see what happens when they leave." Rainey and have been dating on and off for approximately 3 years.

- 3. EV: I took photographs of the text messages but then my battery for my camera died. I used Ofc Sides# 742's camera to finish photographing the text messages. Both film cards were placed into a lockbox at GPD.
- 4. SCA: Rainey was arrested for aggravated stalking (dating violence), and was transported to ASO-DOJ.
- 5. VEH: None
- 6. ADD: I followed LAP protocol and I completed a Judicial Affairs form on Rainey. and completed sworn statements. received a case report number and a victim/witness packet. Rainey refused to complete a sworn statement. UPD was notified.

Upon arrival, I met with Ofc. Bostick, and Ofc. M. Sides, who had already contacted the Complainant, and her sister/Victim I spoke to who reported to me that earlier in the evening, she was supposed to have placed a call to her boyfriend Chris, but fell asleep while watching a baseball game with her sister. stated that Chris, later identified as Christopher Rainey, became upset, and subsequently responded to the home on his scooter. According to , Rainey created a disturbance upon his arrival, and threatened to start throwing things through the windows of the house if she didn't exit to talk to him. came out of the residence and spoke to Rainey, who continued to yell and curse, and accuse of being unfaithful to him. As the encounter continued, `s sister, who was also outside, informed Rainey that she was going to call the Police. It was then that Rainey left, and that began receiving threatening text messages from Rainey. , this activity is completely out of character for Rainey, who is normally very gentle and laid According to back. Both and her sister advised that Rainey doesn't use drugs or even drink alcohol. stated that Rainey, who is a UF football player, has been acting strangely since receiving a head injury in a game played on speculated that Rainey's head injury may be the cause of his actions. 09/11/10.

When asked, told me that she and Rainey have dated on and off for the past 3 years, and that they were , who repeatedly looked exasperated and slightly shaken and confused currently in a dating relationship. during my encounter with her, stated that she just couldn't understand what was going on. She went on to state that she was not fearful at all of Rainey, when she exited the house to talk to him. stated that she was more shocked that Rainey would overreact so drastically, and wanted to reason with him. n stated that upon receiving the text messages from Rainey, her mood changed from shock to fear. I asked pointedly, "Are you afraid", to which she responded "Yes, because of the messages he sent me".

and her sister were informed that due to Rainey's actions, and the fear they created in , Rainey had committed an act of Aggravated Stalking, which was a felony. When both were informed that we had a duty to act became reluctant to proceed in reporting the incident. I mistakenly advised due to the fact that her relationship with Rainey was not a Domestic one, she could complete a Complaint Withdrawal, took several minutes to decide on this, and mostly deferred the decision to and Rainey would not be arrested. n's sister, who was becoming frustrated with , told her that the decision was not hers to make because, "it wasn't my boyfriend who came here threatening to kill us all." ultimately decided to complete a Complaint Withdrawal after she was told by her sister, "I don't care what you do, but I'm taking my nephew 's 8 year old son) and going to stay at our parent's house." stated that she would go with them also, as Rainey would not bother or attempt to contact her at her parent's home.

After researching the Gainesville Police Department General Orders, and Florida State Statutes, I discovered that because Rainey and `s relation should was legally defined as a dating relationship, and the act of Aggravated Stalking is a Domestic/Dating Violence incident, was informed that a Complainant Withdrawal was not possible, and that Ofc. Bostick was bound by FSS and Department Policy to take a pro-arrest action in incidents of Domestic/Dating Violence.

I next responded to the University of Florida campus with Ofc. Bostick, to make contact with Rainey. After making notification of this incident to UPD Sgt. W. Ledger #028, Ofc. Bostick and I contacted Rainey at his on campus dorm room. When asked if he knew why we were there, Rainey responded, "yeah". I confirmed with Rainey by stating "you had an incident with your girlfriend, right?", to which Rainey replied "it wasn't even like that." I stated to Rainey that he couldn't make threats the way he did, to which he replied, "they knew I didn't mean nothing by that." Rainey was placed in handcuffs, and advised of his Miranda Rights by Ofc. Bostick. Rainey acknowledged and waived his rights, and spoke further to Ofc. Bostick, while I retrieved a pair of shoes for Rainey.

I assisted Ofc. Bostick in escorting Rainey to his patrol vehicle, ending my involvement in this incident.
